** TOWN BOARD MEETING MINUTES**

Chairman Paden called the meeting to order at 5:30pm. The pledge of allegiance was recited. Supervisor Curtin and Shultz, Clerk/Treasurer Carter were in attendance. Also in attendance were Lee Moyer, Marian Moyer, Mike Janke, Joe Parr, Paul and Audra Moyer and Jerry Bistram.

The clerk read the minutes. Paden motioned to approve the minutes as read and Curtin 2nd. Motion passed unanimously.

CITIZEN INPUT: Mike Janke requested salt and sand on the town roads especially W River, Skog and Benson especially areas that do not receive sunlight. South River Road West and east side has dangerous ruts. Lee will drag gravel to try to fill in ruts. And He will replace the 'CURVE' sign that was knocked down.

PAUL & AUDRA MOYER: requested assistance with a zoning violation & Land use violation letters they received. They made a request to the town that their 2, ten acre parcels be combined into one 20 acre parcel. Both are zoned AG 2. Motion made by Curtin to approve the request, Supervisor Shultz to 2nd adding, Moyers agreement to retain fire number 15170 Fish Lake Rd as the combined property address and dissolve 15178 as a fire number. Motion passed unanimously.

Chairman Paden advised Paul and Audra to speak to Jason Towne about how to resolve the land use violation. Adding he would assist them in whatever way he is able.

ROADS & CHAIRMAN'S REPORT: Lang did not get crack sealed this year. Will need to be completed next spring. Chairman Paden in process of applying for 90/10 MLS grant for 3 projects

1. 1 mile on Fish lake Road

- 2. Approx. 1/3 mile Benson to Tennessee (Sand Cliffs)
- 3. Approx 1 mile on Benson from Soderbeck connecting to Tennessee

 Deadline for Applications is Dec 6th, 2019.

Lee Moyer reported he took care of a tree down near Shelito's, 2 trees on McLain Rd. There is 1 on Skog and 1 on Hickerson Road that need to be removed. He reported a 2x2 sink hole on Hoffman Rd that will need some gravel fill and to be addressed in the spring.

Shultz gave a summary about Burnett County meeting he attended.

Treasurer presented financial report and invoices to be paid. Curtin motioned to approve financial report and payment of invoices. Shultz 2nd. Motion passed unanimously.
