Chairman Curtin Call to order 6:01 pm 8 people in attendance. Chairman Curtin, Supervisor DeRocker, Supervisor Shultz.

Motion by Chairman Curtin to approve change the agenda order moving Bids up to before citizen input 2nd Supervisor Shultz; Motion Carried.

Approval of Minutes for May 9, 2022 motion to approve minutes & wave the reading Supervisor Shultz made motion, Supervisor DeRocker 2nd. Motion carried.

Road bids opened Paving bid From Monarch 2 foot driveway kick outs and 10 to 15 foot intersection kick out; Graded and shaped to 2%. of 1.32 miles Fish Lake Rd. Motion to accept bid at \$198,391 from Monarch by Supervisor Shultz 2nd by Supervisor DeRocker. Motion Carried

Bids for Crack Seal Farnher and Seal Tech?? 6 short roads Farnher \$29,218 bid Seal Tech clean and fill cracks 15??? And additional 15000. Poly Flex only – see bid. Table Crack sealing to later date for fund and further discussion. Chairman Curtin motion, Supervisor DeRocker 2nd. Motion Carried.

Ditch Mowing bid- Moyer dirt works ditch mowing 2 tractors 7 foot disc mowers at 100 per hour x 2. Est time to mow. Motion to accept bid from Moyer Dirt Works for first mow, DeRocker motion to accept the 100 hr. bid per tractor and check the northern roads but to go ahead with south roads 2nd supervisor Shultz. Motion Carried.

Culvert Borg Rd – replace DNR ok. 36" by 44' \$36000 split cost with county for next year. Fill out permit with DNR good for 5 years. Motion by Chairman Curtin to replace Borg Rd in narrows wetland at an estimate of 36,000 2nd Supervisor Shultz. Motion Carried.

Pot hole repair – 3 to 4 yards of cold mix for whole town to repair. Motion by Chairman Curtin to change 3-4 yards to the town to repair pot holes. 2nd by Supervisor DeRocker.
